1. The Nomination can be made by individuals only holding securities singly or jointly. Non-individuals including Society, Trust, Body Corporate, Partnership firm, Karta of Hindu Undivided Family (HUF) and Power of Attorney holder cannot nominate.
2. The nominee shall not be a Trust, Society, Body Corporate, Partnership firm, Karta of HUF and power of attorney holder.
3. The Security holder [s] can nominate a minor as a nominee and in that event the name and address of the guardian shall be provided.
4. The Security holder (s) shall provide particulars of nominee in the event of death of minor nominee before attaining age of majority.
5. As per section 72 of Companies Act 2013, if the securities are held by more than one person jointly, then the joint holders may together nominate a person to whom all the rights in the shares of the Company shall vest, in the event of death of all the joint holders.
6. If the securities are held jointly, subsequent to the death of anyone of the holders, the securities would not be registered in favour of the nominee but would be transferred in the name of the surviving security holders.
7. The nomination form filled in “duplicate” should be lodged with the Registrar and security transfer Agent of the Company, i.e., **M/s. Karvy Computershare Pvt Ltd, Unit:Kosamattam Finance Ltd**, Karvy Selenium Tower B, Plot 31- 32, Gachibowli, Financial District, Nanakramgunda, Hyderabad - 500 032. The Registrar will return one copy of the nomination form to the Security holder after registering the nomination. The registration number allotted will be furnished to the surviving Security holder (s).
8. The Security holder [s] can delete or change an earlier nomination by executing Form No. SH-14 (Cancellation or Variation of Nomination form)
9. Nomination stands cancelled whenever the securities in the given folio are transferred/dematerialized. Also in case of change in folio due to consolidation/ transmission a new nomination has to be filed.
10. The nomination made through Form No. SH-13 will be considered valid if the nomination made by the holder[s] of the securities is registered with the company before the death of the security holder[s] of the securities.
11. Kindly note that the nomination being a legal document should be dated by the nominator and the witness should certify that the nominator has signed the form in their presence. Furthermore, the date of execution on the Nomination Form should match with the date of witness, witnessing the document.
12. A copy of photo identity proof (like PAN/Passport) of nominee is required.
